



Waiver and Release of Liability Form – Teacher, Parent, Chaperone, or Adult Attending Tour

Assumption of Risk – Tours of Loraas Disposal Services Ltd.'s facilities

Loraas Disposal Services Ltd. ("Loraas") runs an industrial recycling and landfill operation in and around Saskatoon, Saskatchewan.

Loraas provides educational tours of its recycling operations to the public and to school groups.

Loraas provides tours of facilities located at 1902 1st Ave N, Saskatoon, Saskatchewan (the "Facilities").

The Facilities are safety sensitive environments, are active recycling operations and are operational during tours. There is inherent danger involved in being present at the facilities for a tour, including but not limited to:

- Loud noises and flashing lights;
- Moving objects and vehicles;
- Heights and stairs; and
- Other unpredictable dangers associated with an industrial recycling operation.

Attending the tour of the Facilities entails with it risk of injury and damage or loss of property. The risk of attending the tour of the Facilities may be increased if the tour participant suffers from any existing physical or other limitations.

Despite these and other risks, and fully understanding such risks, I consent to be allowed to attend the Loraas tour of the Facilities.

Walking on stairs is a requirement of attending the tour of the Facilities. Wearing personal protective equipment supplied by Loraas at the commencement of the tour is a requirement of attending the tour of the Facilities. Participants in the tour are required to provide their own closed-toe footwear. All attendees must attend, understand, and follow a brief overview of safety requirements prior to starting the tour. Chaperones will be assigned responsibilities in regards to emergency procedures prior to tours. Loraas reserves the right to ask any individual to discontinue the tour at its sole discretion.

Individuals wishing to take the tour of the Facilities with disabilities or mobility or other restrictions should contact Loraas in advance of the tour at (306) 242-2300, and Loraas may accommodate such disabilities or mobility or other restrictions where reasonably possible. For safety purposes, any individual with significant mobility or other restrictions will require an individual chaperone to attend the tour with them.

I recognize and understand that attending the tour of the Facilities involves certain risks and I agree to entirely assume such risk, including risks created by any negligent actions of other individuals on the tour, Loraas, and any Loraas employees.



I recognize that if I am attending the tour of the Facilities as a teacher or chaperone:

- I will be responsible for the safety and well-being of the students on the tour of the Facilities;
- That at least two adults, whether they are teachers or chaperones, must attend the tour of the Facilities, and that additional chaperones may be required to accommodate any disabilities or mobility of other restrictions;
- For safety reasons, any individual with significant mobility or other restrictions will require an individual chaperone to attend the tour with.

I understand and agree that Loraas, its directors, owners, agents, clients and employees, (collectively, the "Releasees") are not responsible for any injury (including death) or loss of property suffered by me while touring the Facilities or as a result of touring the Facilities for any reason whatsoever, including any potential negligence or willful misconduct on the part of the Releasees.

I have read and understood this agreement. I hereby release the Releasees from any and all liability arising from the tour of the Facilities. I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns.
